Item 2 - Educational Background and Business Experience

Charles Guilbault was born in 1980. He received a Bachelor of Science from the University of New Orleans. He became the Chief Executive Officer and Chief Compliance Officer of Guilbault Capital in April 2024 and an Investment Adviser Representative of the firm in August 2024. Prior to this, Mr. Guilbault was an Investment Adviser Representative with Wells Fargo Clearing Services from July 2015 to August 2024.

Item 3 - Disciplinary Information

Item 4 - Other Business Activities

Charles Guilbault is a licensed insurance agent and can receive commissions, and in some instances, ongoing compensation called trail commissions for the sale of fixed insurance products. This compensation gives him an incentive to recommend insurance products in addition to advisory services.

Mr. Guilbault also serves as the Chief Financial Officer and Chief Administrative Officer for MedCentris, a wound medicine company. In this capacity, he is responsible for high-level strategic financial decisions and planning. This activity provides a substantial source of Mr. Guilbault's income and involves a substantial amount of Mr. Guilbault's time. MedCentris is owned by a client of Guilbault Capital, which gives Mr. Guilbault the incentive to provide preferential treatment to this client.

Additionally, Mr. Guilbault serves as the Chief Executive Officer of MolecuLab, where he is responsible for the overall management of the company. This activity provides a substantial source of Mr. Guilbault's income and involves a substantial amount of Mr. Guilbault's time.
